1. Call to order

a. Y. Scoggin called the meeting to order at 5:03 pm.

2. Chair's Report & Announcement of the Order of Business:

a. Introductions- With new residents in the room, Y. Scoggin started with introductions

3. Public Comments:

a. ATV Concerns- Linda attended the meeting to discuss the noise created from the security ATVs. They wake her up every 15 minutes late into the night nearly every night. This has been a recurring concern for residents in the neighborhood, so the Board will discuss solutions with Jim Whyte of the Neighborhood Security Initiative and Rob Betts of The City's Finest.

4. Public Safety

- **a. NSI Update** J. Whyte was not available to present the NSI Security Reports, so members reviewed the printed report given to them. Total crime is down 12.33%, total person crime is down 30.00% and total property crime is down 9.52%.
- **b.** Cameras- The Board requested PCD ask J. Whyte if the arrest in the report could be attributed to the cameras in the SBD.

5. Neighborhood Improvement:

- a. R. Coleman reported the following
 - i. Jimmy and Andy's bar received their liquor license for 1:30 AM and Sundays. There was a protest, but there were not enough signatures.
 - ii. There are no updates on the proposed Montessori School.
 - iii. Trailnet parklet is ready to move forward pending financial contributions.
 - iv. Vandeventer and Laclede crosswalks have been repainted.
 - v. Forest Park Medians: residents are working with R. Coleman and the Parks

 Department to plantings on the Forest Park Medians from Newstead-Sarah. They
 are trying to set up meetings with Mike Sullivan of Cortex and other stakeholders in

- vi. Lighting at 4300 and 4400 of Laclede needs to be updated. The SBD agreed to prioritize this project and R. Coleman will begin collecting bids for the project.
- vii. Some residents have expressed concerns about unused driveways and would like to explore landscaping and trees for those drives.
- viii. The lights behind 4100 Laclede Condos cannot be fixed without digging under private property, so there will be some consideration on solutions.
- ix. Painted arcs at the intersections are being proposed. R. Coleman will come back with firm prices.
