- 1. Call to order:
  - a. D. Anderson called the meeting to order at 5:04 PM.
- 2. Chair's Report and Announcement of Order:
  - a. None.
- 3. Approval of previous Meeting Minutes:
  - **a.** R. Kissel motioned to approve meeting minutes; B. Jones seconded. All in favor, motion approved.
- 4. Public Safety:
  - a. Neighborhood Security Initiative: J. Whyte gave an overview of the previous month's crime data, noting an increase in crime primarily due to vehicle thefts. J. Whyte noted the heavy increases in cost for secondary security as well as loss in patrol coverage and discussed ways of addressing the issue. J. Whyte shared that the NSI is considering their own patrol services though they would face the same challenges with moral and burnout that other secondary patrol services are struggling with. D. Anderson discussed reaching out to neighboring districts to see if secondary patrols could be shared while on shift.

#### 5. Neighborhood Improvements:

- a. R. Colman gave the following community updates:
  - i. The Laclede lighting project is moving along well, and there is no to disturb most of the sidewalk or landscaping for the project. Instead, the project will bore holes under the sidewalk for the electric. The next steps will be for BPS to start bids.
  - ii. The pedestrian lights have been ordered but are on backorder.
  - iii. The Forest Park Ave planter water pipes that were broken have been mostly repaired.

- b. Tree Watering: C. Holt shared that Toni Trotter (ATBM) has been providing emergency watering services for trees, and that the board should expect an invoice from him soon. After discussion, D. Anderson motioned to expand T. Trotter's current services with the district to include watering of trees; R. Kissel seconded. All in favor motion passed. R. Coleman requested that Park Central send him the invoice to see if Toni's prices are competitive with other watering services in the area.

Coleman shared that next steps would include asking the alderperson to fund a portion of the project and to conduct a formal walk assessment and cost estimate.
- b. R. Coleman asked on behalf of Brooks Goedeker if the board would be interested in helping fund a crosswalk between the Element Hotel and the Foundry. After discussion, the board showed interest in assisting financially.
- c. J. Miner shared that the new watering system at 3100 Laclede has been working great but has been hit by a car twice. The system is still working, but J. Miner recommends bollards. R. Coleman shared that he would ask about the city placing a bollard in front of the system.
- 8. **Meeting Adjourned:** J. Miner motioned to adjourn; B. Jones seconded. All in favor meeting adjourned at 6:06 PM.
